

Certificate of Character referee report

Fit and proper person

When considering whether a candidate is a fit and proper person to be admitted, the New Zealand Law Society (Law Society) takes into account the functions required for the practice of law. This is essential to enable regulation of the profession in a way that protects both consumers of legal services and the wellbeing of practitioners.

These functions include (but are not limited to): adhering to lawyers' fundamental ethical obligations to clients and the courts; and making careful judgments sometimes in time critical and stressful situations. It will also be relevant to consider any behaviour which may potentially impact adversely on clients, other members of the legal profession, or members of the public.

While it is expected that candidates would declare a persistent or recurrent condition, minor mental health matters and one-off episodes of illness need not be declared, nor mild anxiety during exam time. Referee information

Referees must be either the candidate's employer or a 'preferred referee'.

Some examples of preferred referees are as follows:

- Lawyers (i.e. someone with a current practising certificate)
- Currently registered: Authorised financial advisors, Chartered accountants, Dentists, Engineers, Legal executives, Social workers, Marriage celebrants, Medical doctors, Nurses, Physiotherapists, Occupational therapists, Pilots, Real estate agents, Teachers, Veterinary surgeons.
- University lecturers and professors who know you outside of university or in the capacity of an employer
- Elders/pastors from a church, temple, mosque or synagogue
- Justices of the Peace
- Serving members of the armed forces

- · Serving police officers
- Senior government officials
- Members of parliament

Who cannot be a referee?

- Members of the candidate's family (including spouses, partners, in laws and those connected to the candidate by civil union or de facto relationship).
- Your health professional.
- University lecturers and tutors unless you are acquainted with the candidate outside of the university or you have known them in the capacity of an employer.
- The wife/husband or de facto partner of someone who has already provided a reference.

If you are unsure of whether the provisions of the Criminal Records (Clean Slate) Act 2004 may apply to any previous conduct by the applicant, you should discuss this with them in advance of completing this form.

Please answer the questions in this form as fully as possible.

Inadequate responses may delay the processing of the candidate's application.
